# Terms, Conditions and Cancellation Policy

## Travel Arrangements

Ground transportation in and around Paris for the duration of the program is included in the trip price. Guests are responsible for their travel arrangements to join the group for morning visits (at Notre-Dame de Paris and in the 8th arrondissement) and to return to their homes/lodgings following the end of each day.

## Accommodations

Trip participants are responsible for making their own hotel reservations. FHS members receive preferential upgrades and treatment at Le Bristol, Paris - be sure to mention your membership if you book with them. We recommend making hotel reservations as soon as possible due to the impact of the 2024 Olympic Games on Paris tourism.

## Reservations and Cancellations

**As space is limited, reservations will be honored in order of receipt of reservation form accompanied by the appropriate payment. Payment balance must be received by Wednesday, February 21st, 2024.**

Cancellation must be received in writing (including by e-mail) at French Heritage Society's New York City office. All refunds resulting from cancellation will have a \$200 per person fee deducted. Membership payments or monies designated as a tax-deductible contribution are not refundable.

-Cancellations received on or before Wednesday, February 21st will result in a refund of any non-tax deductible portion of the trip price per person.

-Cancellations received on or before Friday, March 15th will result in a 50% refund of any non-tax deductible portion of the trip price per person.

-Cancellations received after Friday, March 15th will necessitate forfeiture of the full non-tax deductible portion of the trip price per person.

Should cancellation by a participant be a result of an act of God or an act of war, any non-deductible portion of funds previously paid by the participant will be applied to such liabilities/penalties that FHS has incurred on behalf of said participant with any remaining balance, less the \$200 administration fee, to be refunded to the participant. FHS recommends that participants obtain comprehensive travel insurance to protect against loss of payments for individual travel arrangements.

If program changes should become necessary, substitutions, on par with the quality of the program, will be made by FHS.

By signing and returning this Reservation Form, you acknowledge that you have read and accepted the terms and conditions as indicated. You specifically waive any and all claims or causes of action against French Heritage Society, its Board of Directors, its staff and its representatives in case of any loss of or damage to property, accident, or injury in connection with this program.
